# Footloose Fridays Dance Rules



- No offensive language
- All guests and their chaperones/providers must leave the dance location within 20 minutes of the end of the function. No loitering in the parking lots.
- Chaperones are subject to abide by all the rules of the dance.
- All bags, purses, jackets or other hand-carried items are subject to inspection.
- All participants, chaperones and providers must stay within the designated dance areas. These areas are posted.
- Providers must stay with or in sight of participant during the dance.
- The dance committee reserves the right to dismiss a patron or caregiver at any time they feel the dance environment or individuals participating are not contributing to a positive and safe event.
- All attending the dance must sign off on the rules.
- If VGC is closed due to inclement weather or emergency, no dance will be held that evening.

I agree to remain tobacco, drug and alcohol free for this event and follow the dance rules. If drugs are found, I acknowledge that the local police will be contacted and that I will have to abide by the local city/county rules and ramifications. I acknowledge that my failure to comply with these rules will result in my ineligibility to attend further dance events.
