NOTICE TO BIDDERS

Sealed Bids for the Lake County Board of Developmental Disabilities (LCBDD)/Deepwood Broadmoor School Courtyard Concrete Project will be received by the LCBDD's Director of Operations until 11:30 AM, Eastern Daylight Savings Time, Friday, June 10, 2022 at the LCBDD Administration Building, 8121 Deepwood Blvd., Mentor, Ohio 44060.

All Bids will be opened and read publicly and recorded immediately thereafter. LCBDD may choose to not award the Bid until thirty (30) days after the Bid opening. The work for which Bids are invited consists of the furnishing of all labor, materials, and equipment required for the removal of vegetation, tree stumps, door slabs and sidewalks, and replacement with Concrete at 8090 Broadmoor Road, Mentor, Ohio. The work must be completed by August 15, 2022.

The major work will consist of the (approximate) following: Demolish existing planter and stockpile commemorative brick for reuse, remove existing vegetation and tree stumps, remove existing sidewalk and door slabs, connect new catch basin approximately 40' from existing catch basin, excavate existing lawn area to obtain a 36' x 95' concrete patio area, and replace the six (6) door entrance slabs with monolithic concrete frost free slabs. *Note: A crane will be required to facilitate lifting a small excavator and skid steer into courtyard.*

Each Bid shall contain the full name and addresses of each person or company interested in the Bid and shall be accompanied by a Bid Guaranty in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in bond form shall be issued by a surety company or corporation licensed in the State of Ohio to provide such surety.

LCBDD reserves the right to accept or reject any or all Bids, to waive informalities or irregularities in the bidding process and to enter into a contract with the Bidder whom, in its opinion, offers the lowest responsive and responsible Bid.

Proposals should be in a sealed envelope, addressed to Director of Operations, Lake County Board of DD, 8121 Deepwood Blvd., Mentor, OH 44060 and be clearly marked as "BID FOR BROADMOOR COURTYARD CONCRETE PROJECT."

A Pre-bid meeting will be held at 10:00 AM, Thursday, June 2, 2022 at the LCBDD Broadmoor School, 8090 Broadmoor Rd., Mentor, Ohio 44060.
