I. SUBJECT: BROADMOOR POOL

II. PURPOSE:

To implement policies/procedures that will ensure the safe, appropriate use of the swimming pool at Broadmoor School.

IV. POLICY

It is the policy of the Lake County Board of DD/Deepwood to promote the proper use of the Broadmoor swimming pool to ensure a safe aquatics environment, enhance aquatics skill attainment, provide recreational activities, and provide associated therapies for each participant. The safety and security of all participants is of primary importance when conducting any aquatic activity.

Pool Usage:

In recognition of this responsibility, the guidelines contained within the Broadmoor Procedures Manual shall be implemented for all school-related activities.

In very limited circumstances, the Board may allow certain third-party entities to use the Broadmoor School pool for aquatic activities. Any entity that seeks to use the Broadmoor School pool for a non-school-related activity must seek pre-approval from the School Principal and the Agency Superintendent. Such requests for pre-approval must be in the

format of the attached Facility Usage Waiver Form, and must contain the security procedures, lifeguard certification, insurance information, and all other assurances necessary to establish that the entity can safely and adequately conduct the aquatic activity specified. Any third party activities at the Broadmoor School pool shall **only** be for the benefit of individuals with disabilities, who would otherwise be eligible for Board services. Such requests for preapproval may be granted or denied at the sole discretion of the Agency Superintendent, or his/her designated representative.

At all times during any activity conducted at the Broadmoor School pool, whether by a Board employee, or a third party entity, **ALL** water safety procedures outlined within the attached Broadmoor Procedures Manual must be followed.
