Following an extensive compliance survey conducted by the Ohio Department of Developmental Disabilities in June 2024, LCBDD was awarded the highest level of County Board Accreditation. Accreditation was awarded effective upon current Accreditation's expiration date of November 1, 2024, and remains effective through October 31, 2027.

The Survey Team commended the LCBDD for all programs, services, and efforts, and specifically noted the following initiatives and programs felt to be above and beyond minimal compliance:

- Tech Suite developed and opened by the County Board where people can explore various tech through scheduled tours or by booking a weekend overnight stay (overnight visits available starting in Fall of 2024)
- Recreation Department Program growing through provider network support and outreach to help more people get involved in meaningful activities
- > SSAs have a family culture and go above and beyond to support one another
- SSA Training and Mentorship Program effective and specialized SSAs have added depth to what the County Board can offer (e.g., Mental Health, Transition, Community Life, Employment Navigation)

Community Awareness/PR Opportunities/Collaborations

Preschool and Early Intervention families attended a picnic with the Recreation Department in July at a splash park in Painesville. Families enjoyed chicken nuggets provided by the Broadmoor Family Net-Work, and were able to play and enjoy connecting with each other.

Broadmoor School Staff came in two days in August to work with the State Support Team 4 to develop Broadmoor School's framework for Positive Behavioral Interventions and Supports (PBIS). This will be a yearlong process before full implementation building wide; however, it will be grounded in the expectation to Be Kind, Be Safe and Try Your Best.

The Willoughby Branch (WB) collected items for two community entities during the month of July, the School Supply Drive and the Natural History Museum. School supplies were then dropped off to a location for collection and the individuals were very excited to be a part of that volunteer activity. We also collected old towels and sheets for the rescued animals at the Natural History Museum and those animals will now be much more comfortable in their homes thanks to the generous donations from WB.

The CES Department staff and managers volunteered at the United Way on Friday, July 26, sorting clothing and books as well as moving boxes for the Back to School Bash as a way to work together while giving back to the community.

We greatly appreciate our partnerships with local media outlets that facilitated a wealth of articles throughout July and early August. By doing so, we reach many community members who do not follow us on social media or who might not have an awareness of our supports and services. We secured media coverage for Special Olympics Law Enforcement Torch Run, Deepwood Idol (pre-

Individuals and their families were invited to join in an outdoor event including an ice cream bar with a variety of toppings, water balloon toss, sensory area (sand play, bubbles and sidewalk chalk) outdoor games and the ever-popular dunk tank! In total, 28 participants and family members enjoyed the event and had opportunities to socialize, meet the recreation and transition team, eat ice cream treats, and overall have a family-friendly and fun evening. The LCBDD Transition and Recreation Departments host quarterly family-engagement activities to encourage agency participation for youth who are eligible for LCBDD services. We are looking forward to our upcoming Fall Festival in September!

The Community Advocacy group met at Chagrin River Park on July 30. Lake Metroparks Lieutenant Walsh came to the Advocacy meeting at Chagrin River Park and shared about the parks and park safety. He taught the group about deer and showed different antlers found in the many parks. The self-advocates enjoyed the engaging experience!
